ORDINANCE ---- 1ST READING ----**ORDINANCE** INCREASING THE AMOUNT OF FUNDS CONTRIBUTED BYTHE CITY OF GLASGOW FOR ECONOMIC DEVELOPMENT FROM \$60,000.00 TO \$120,000.00 TO BE INCLUDED IN THE BUDGET FOR FISCAL YEAR 2019-2020 AND DESIGNATING THAT SAID CONTRIBUTION SHALL **NOT** BE**USED** FOR **SALARIES** ADVERTISING BUT SHALL BE UTILIZED ON PROJECTS **ONLY** AND **PURSUANT** TO AN **INTERLOCAL** AGREEMENT TO BE NEGOTIATED WITH THE BARREN FISCAL COURT WHICH IS PROVIDING **SIMILAR** FUNDING FOR ECONOMIC DEVELOPMENT

A proposed ordinance was presented for the first time and caused to be read for the first time.

MOTION was made by Council Member Honeycutt for the first reading approval of the

Ordinance

Prior to the vote, discussion ensued regarding this proposed ordinance. Council Member Gaunce asked if the county and fiscal court had already agreed on all this? Mayor Armstrong affirmed. Gaunce asked who was going to run this? Mayor Armstrong replied with "The Economic Development Board for the City.... along with me (Armstrong)." Gaunce asked if this would be the GEDL? Mayor Armstrong said that it would only have Council Members on this. He said that the City would have a new council set up for it and there may be a joint committee between the city and county, but for the time being, it would just be the Council Members here would be on that committee. Council Member Gaunce asked if the Council was going to be able to see what the money would go for before it is voted on. Mayor Armstrong said if any group came in

for incentives, it would go before the committee and then that group would bring before the Council for the final vote.

Council Member Groce brought up that our current budget is \$55,000 for IDEA, not \$60,000. Mayor Armstrong said that it may be \$55,000, but the total amount that was spent the last three (3) years was \$60,000. Groce asked if the original \$55,000 would still go to IDEA and the additional \$120,000 would go to this other committee. Mayor Armstrong said, "No, it's entirety would stay right here within this body". Council Member Gaunce asked if we were just doing away with IDEA? Mayor Armstrong said for this year (2019-2020), that their director has retired and if they are going to hire another director and it looks like it's going to be a good deal, then this board can come back and reallocate money to that. But at this time right now, he doesn't think that the majority of the people are happy with the way things have been going, so we are going to try to do better.

Council Member Bunnell appreciated the increase but thought that there were too many restrictions in the ordinance. By not having money available for salaries and advertising was too restrictive to the city. He believes that these restrictions will hinder us in the future. Mayor Armstrong said that the GEDL Board said that they would come forward with funds for advertising and a salary if needed. Mayor Armstrong offered that Council Member Bunnell could amend the motion. Again, Bunnell said that he thought this was going to clamp us down too much. Mayor Armstrong said that we are basically mirroring the county and what they have already done. However, if someone doesn't think that they GEDL committee would step up, then you are welcome to make an adjustment.

Council Member Groce said that they way that he understood it that the county didn't have any restrictions and that they just allocated it to the IDEA Board. Mayor Armstrong said that was wrong.

Council Member Gaunce asked that since the county was already ahead of us, wouldn't it be better to look at what they've done. Mayor Armstrong said that this (proposed ordinance) is modeled after what the county has already done. Gaunce wanted to see the exact document.

Council Member Honeycutt pointed out in the audit the amount of funds that the Economic Development had at year end. However, Gaunce asked the question is it in our best interest that Frankfort see that we have 3 different groups working independently of each other. Mayor Armstrong said that he had spoken to Frankfort that morning and put a deal on the table and it was more than what had come out of the IDEA Board in years. Mayor Armstrong said that there were things going on and it was up to this group on what they wanted to do.

Council Member Trigg asked the Mayor if the intent of this ordinance is to defund the IDEA Board. Mayor Armstrong said that it was to get jobs in here. Trigg clarified by stating, that he (Mayor) was wanting to take the \$55,000 that was slated for the IDEA Board and move that to a new interlocal agreement that hasn't been established yet and move that up to \$120,000.00. Mayor Armstrong stated that they were going to change the existing interlocal agreement, we aren't going to start a new one but change the one that we're in now. And have those funds available for this board and the economic development committee to work with.

Council Member Gaunce spoke to the original interlocal agreement and it was originally in order to receive grant money that it had to be an arms-length transaction but if the county has already made theirs, and they are no longer with IDEA, he would feel more comfortable voting on it once they could see the county's and see more data.

Council Member Gaunce asked that if we couldn't wait for two weeks to gather more information, get a copy of the Fiscal Court's papers, and see what the announcements are going to be in the next two weeks before making a decision on the ordinance.

Council Member Norris asked for clarification on the GEDL committee saying that they would put in money if needed. Mayor Armstrong said that in the GEDL last meeting, the committee said that if funds were needed for advertisement from them, that they were available.

More discussion regarding whether to do an amendment, hold off for two weeks, or go ahead with the vote. More discussion regarding the funding of the GEDL fund and where that money came from. More discussion on how the IDEA is funded, how the members are placed, and how the voting procedures work.

Council Member Kirkpatrick had two questions regarding. One was for Bunnell to explain his concern with the restrictions on the ordinance. The next question was for the Mayor that once the money is gone from the GEDL fund, where would the money come from for salaries and advertising? The Mayor said that we would have to do like we did in 1983, we would have to come up a way to generate funds and hopefully have enough jobs to allocate some of the payroll taxes to replenish that.

Mayor Armstrong called for a vote. With being unable to detect the voice vote, Mayor Armstrong called for a roll call vote.

After discussion, Mayor Armstrong called for a vote.

Kenny Hardin, Glasgow Area Ministerial Association (GAMA) addressed the council regarding an Emergency Shelter in Glasgow. Mr. Hardin presented the council with two (2) handouts. One being information regarding "Room in the Inn" in Bowling Green and the other being a narrative from Pastor Jim Rose. Mr. Hardin started with that GAMA had worked with past Mayor Doty and has worked the past few years in ways to address the issue of homeless shelters. As GAMA started looking at homeless in Glasgow, there isn't a large population of homeless. They see a greater need for people during the winter with people in need of emergency shelters during the winter. The shelter would be available during the dates of November 15th through March 15th and be rotating through to provide a night's shelter during inclement weather. There would be a central location where people could come together that would need services, then churches would come pick them up and provide them with a meal and a place for them to sleep at night, breakfast, possibly a snack lunch and then taken back to the place they were picked up at and dropped back off.

The basic report that he wanted to share with the council was as a ministerial association, they are talking to the churches that are a part of that but are going to take it wider and take it to the churches that are part of the Liberty Baptist Association. Then by this coming November to have as many churches on board and ready to implement this in our county.

Mr. Hardin explained that the definition of homelessness takes on different things. As their research has shown, there isn't a great population in our community, but they want to address it as a spiritual organization responding to God's call. As church, they are going to try to provide a place for people to come during inclement weather. This would be one night's stay that would rotate between different churches in town and provide a meal. Not on a 30-day basis such as the Edmonton facility.
