INTENT

NFPA standards require that each fire department shall maintain a Training Program for all department personnel. The Fire Department shall make every effort to comply with NFPA standards.

NFPA STANDARDS FOR TRAINING

1. Firefighter's professional qualifications: All personnel shall be trained in compliance with NFPA 1001 levels I – III.
2. Driver/Operators: All personnel shall be trained in the driving and operating of fire apparatus as per NFPA 1002.
3. Fire Officers Professional Qualifications: All Fire Department Officers shall be trained in compliance with NFPA 1021 at all levels.
4. Fire Inspector Professional Qualifications: All personnel shall make inspections and shall be trained in compliance with NFPA 1031
5. Fire Investigator Professional Qualifications: All personnel shall be trained in investigation as per NFPA 1033 and 404M. Also reference sections 116 and 124.
6. Fire Service Instructor Qualifications: The Fire Department Instructor shall be qualified in compliance with NFPA 1041 also reference sections 104, 105, 111, 113, 114, 115, 116, 117, 122, 123, 124, 130, and 133. Shall fall within the duties of Administration Officer.
7. Fire Department Safety Officer: The Fire Department Safety Officer shall be trained and qualified in compliance with NFPA 1501. Also reference section 133. This is also one of the Administrative Officers Duties.
8. Public Fire Educator Professional Qualifications: The Public Educator shall be qualified in compliance with NFPA 1035, and this shall be the duty of the Administrative Officer.
9. Public Fire Prevention: Public Fire Prevention shall follow NFPA 1301, and personnel shall be trained according to NFPA 1301 and shall be supervised by the Administrative Officer. Also reference section 104.
10. Training Reports and Records: Training shall follow NFPA 1401, and all records shall be complete in accordance with the training standard. Also reference sections 103, 104, 124, and 130.
11. Accreditation of Fire Protection Education Programs: Personnel shall be trained in compliance with NFPA 1461.
12. Live Fire Training: All live fire training shall be conducted in compliance with NFPA 1403 and section 133. **NO EXCEPTIONS** due to the hazards involved.
13. Initial Fire Attack: All personnel shall be trained individually and as companies in compliance with NFPA 1410.

14. Self Contained Breathing Apparatus: All personnel shall be trained in the use of SCBA and in compliance with NFPA 1981. Also reference sections 116 and 121.
15. Spray Nozzles: All personnel shall be trained in accordance with NFPA 1964. Also reference sections 110, 111, 113, and 114.
16. Wildfire Control: Training for personnel shall follow NFPA 295. Some special training may be given for fire plow operation.
17. Hazardous Materials Identification: All personnel shall be trained in compliance with NFPA 704. Also reference sections 220, 221, 223, 224, 225, and 207.
18. Automotive Fire Apparatus: Training shall follow NFPA 1901. Also reference sections 120, 122, and 207.
19. Service Test of Fire Apparatus: Personnel shall be trained to perform service test in compliance with NFPA 1911. Also reference section 123.
20. Fire Department Aerial Devices: All personnel shall be trained in the use of aerial devices in compliance with NFPA 1914. Also reference sections 120, 122, and 207.
21. Fire Department Portable Pumping Devices: All personnel trained in the use of portable pumps in compliance with NFPA 1921
22. Ground Ladders: All personnel shall be trained in the use of ground ladders in compliance with NFPA 1931.
23. Fire Hose: All personnel shall be trained in the use and care of fire hoses in compliance with NFPA 1961, 1962, and 1963. Also reference sections 110, 113, 114, and 211.
24. Fire Prevention Codes: All personnel shall be trained concerning fire prevention codes in compliance with NFPA 1.
25. Portable Fire Extinguishers: All personnel shall be trained in the use and identification of extinguishers in compliance with NFPA 10.
26. Foam Application: Training in the use of foam will be in conducted in compliance with NFPA 11, 11A, 11C, and 16.
27. Fire Service Organization: Personnel shall be trained in compliance with NFPA 1201 and 1202. Also reference sections 100 and 101.
28. Fire Safety Concepts: All personnel shall be trained in safety concepts in compliance with NFPA 550. Also reference section 133 and NFPA 1500.
29. Fire Fighting Operations: All training shall follow NFPA 178. Also reference Command Procedures.
30. Flow Testing and Marking Hydrants: All personnel shall be trained to conduct hydrant test in compliance with NFPA 291. Also reference article 111.
