### **ORDINANCE NO. 2022-3009**

AN ORDINANCE RELATING TO AMENDMENT OF THE RULES AND REGULATIONS AFFECTING COLLECTION OF GARBAGE IN THE CITY OF GLASGOW, KENTUCKY. THIS AMENDMENT UPDATES RATES IN ORDINANCE NO. 2019-2941 DATED SEPTEMBER 9, 2019

WHEREAS, the City of Glasgow, Kentucky, due to changing circumstances and conditions, does now require an amendment to their garbage collection rules and regulations;

**NOW THEREFORE, BE IT HEREBY ORDAINED** by the City of Glasgow the amendments to the Rules and Regulations are as follows:

# Section No. 1: 50.16 GARBAGE COLLECTION MANDATORY.

(A) Garbage collection by the City's Sanitation Department shall be mandatory at all residential units within the City limits.

## Section No. 2: 50.17 CONTAINER SPECIFICATIONS.

- (A) It shall be the duty of owners, tenants, or persons in charge of every dwelling, house, store, manufacturing establishment, office building or other buildings in the City to place, or caused to be placed, all garbage and refuse accumulated on the premises in official, City of Glasgow roll dumpsters, or it will not be collected.
- (B) Carts must be at your curb no later than 7:00 a.m. the day of your collection and no earlier than 6:00 p.m. the night before. Trash that has been disturbed by wind or animals is considered litter and will not be picked up by the City; it is the responsibility of the occupant. There shall be no household garbage in plastic bags outside the cart.
  - a. Do not overload the cart (maximum load of 200 lbs.). This will cause unnecessary damage to the carts.
  - b. Do not place hot ashes, paint, solvents, oil, liquids of any kind, hot charcoal, batteries, hazardous waste, construction debris, auto parts, junk items, dirt, rocks, or any other items not normally found in household waste in the cart.

- c. Do not put yard waste in the cart.
- d. The cart must be kept clean to comply with health and sanitation requirements. Wash the cart periodically with detergent and water.
- e. Keep the lid of the cart closed at all times except to place garbage in the cart. This will prevent water from entering and placing unnecessary weight on the cart. It will also prevent trash from blowing out, the entry of insects and the entry of animals.
- f. Do not let children play in or with the cart.

#### Section No. 3: 50.18 LOCATION OF CONTAINERS FOR COLLECTION.

(A) Carts must be positioned at the edge of the curb and at least three (3) feet away from other carts, walls, buildings, poles, etc. DO NOT block sidewalks.

**Section No. 4:** All of Section 50.19 is deleted.

## Section No. 5: 50.20 RATES FOR GARBAGE COLLECTION; DISCOUNT.

(A) The minimum monthly rates for collection of garbage hauled in City packers is as follows:

(B) (2) All persons claiming the discount shall, on or before the first day of the birth month, of each year, complete and file with the Glasgow City Hall Administrative Clerk, on a form prescribed and made available by the Administrative Clerk, the claim for discount provided in this division. The claims shall be effective for the twelve (12) month period following the first day of the birth month of each year. New garbage collection customers during such twelve (12) month period, and persons attaining the age of sixty-five (65) years or becoming disabled during the twelve (12) month period, may make the claim for discount after the first day of the birth month of each year.

Section No. 6: Section 50.21 (B) and (E) are deleted.

# Section No 7: 50.35 DISPOSAL OF GARBAGE AND REFUSE AT THE LANDFILL (GLASGOW REGIONAL LANDFILL).

(C) (7) All customers of the Landfill shall receive a numbered receipt for payment whether paid by cash, card, check, or monthly billing, the receipt shall include date, name of commercial hauler and/or individual, time of day, weight, origin, and type of garbage and/or refuse.
