

The right-of-way varies throughout the city of Glasgow. As a general rule, it includes streets, curbs, medians, traffic lights, utility poles, and

unimproved shoulders of the streets up to private property and generally three feet beyond sidewalks. Placing signs in these areas is illegal. Posting your signs isn't just illegal, it's unsightly and can be dangerous to the public.

Grass and Brush Disposal



It is against City ordinance to throw grass, weeds, leaves, brush, rocks, or trash on roadways, sidewalks or in drainage ways. This causes clogged drains and can cause roads to be slick and dangerous.



Address numbers

When life threatening and emergency situations occur police, fire, and EMS need to locate properties as quickly as possible. In order for them to reach you, it is critical that you have a correct and visible address. Numbers should be in a contrasting color from the mounting surface and visible to vehicles traveling in either direction on the fronting road.

Types of Permits

These regulations are local laws adopted by the Glasgow City Council to promote health and safety, protect the community from blight and deterioration, and enhance the livability of the City of Glasgow.

The code enforcement process is generally initiated by a concerned resident reporting a possible violation. Most cases are resolved by the property owner/ responsible party responding to formal notification of the violations.

When voluntary compliance is not obtained however, the city will pursue civil citations, criminal charges or contractual abatement until the violations have been resolved.

A Quality Neighborhood Starts With You

Blight conditions in neighborhoods can negatively impact property values, encourage crime and discourage other homeowners, business owners and tenants from maintaining their own properties.



Outside open storage on residential properties is prohibited. This includes inoperable vehicles, auto parts; stove, glass, building or landscaping

materials, building rubbish; dead trees, trash, garbage, or similar items. It must be contained inside a building. There are specific regulations that apply to outdoor storage and use on properties zones for other than

Property owners are responsible for keeping their properties and the adjacent right-of-way free of dead or dried



vegetation (weeds, tall grass, shrubs, trees, etc). All dead or dried vegetation must be removed and disposed of properly. Property owners are also responsible for assuring the grass and weeds on their property and in the adjacent right-of-way do not exceed eight inches in height.

Yard Sales

Permits ae required and available at City Hall, no charge. No more than 1 yard sale during every calendar quarter at any residential location. Yard Sales can be conducted over no more than a 48 hour period.

No inoperative or unlicensed vehicle shall be parked, kept, or stored on any premises. No vehicle shall be in state of major disrepair, disassembly, or in the process of being

stripped or dismantled. Painting of vehicles is prohibited unless conducted inside an approved spray booth. A vehicle is permitted to undergo major overhaul or body work provided it is inside a structure that is approved for such purposes. Car covers, tarps, shades and other similar materials are not acceptable structures.

Junk, Litter and Debris




Junk, litter and debris cannot be left on the property. It must be disposed of properly. This includes discarded or broken auto parts, furniture, building and/or

landscaping materials and tires; litter such as discarded paper, cardboard, plastics, etc.; debris such as tree trimmings and fallen limbs or any other items that have been discarded. You will have to take this to the landfill as the City will not pick it up.

It is the duty of the occupant to place all garbage in an official trash container. No household garbage in plastic bags outside the cart will be



collected. Carts must be at your curb no later than 7 am on your collection day and no earlier than the day before. Please return cards behind the front corner of the residence after pick up. Do not place in container any hot ashes, paint, solvent, liquids, hazardous waste, construction debris, auto parts, dirt, rocks, or other items that not normally found in household waste.



Property owners are responsible for maintaining structures and grounds of a property. All vacant structures must be kept secure so they cannot be opened from the outside.

A property owner may be required to board up a structure to city specifications if it becomes vacant and is not secure. Accessory structures on the property, such as storage sheds and garages, must also be secured to city specifications. Boarding up a structure is a one time, temporary securement option. Rehabilitation or demolition of a structure may be required
