A \$150.00 per day thereafter will be assessed against the purchase price with the total not to exceed 2.5% of the purchase price. Pursuant to 45A.080 (2) If the delivery is late, the bidder shall be given the opportunity to present evidence that the cause of the delay was beyond his control. If the cause is sufficient justification for delayed delivery, the City may adjust or waive any penalty that is provided for in bidding documents.

Warranty information for equipment must be provided with the bid.

The City of Glasgow – Department of Public Works reserves the right to reject any and all bids. Bids must be good for 90 days.

In compliance with the above, the undersigned offers and agrees, if this bid is accepted within ninety (90) calendar days from the date of opening, to furnish any and all of the items upon which prices are quoted, at the price set opposite each item, delivered at the designated point(s) within the time specified in the schedule. Items on bid are exempt from federal excise tax and Kentucky sales and use tax. Title shall pass to the City upon actual receipt and acceptance of the items. In the event there is a discrepancy between the unit price and the extended price, the unit price shall govern.
